In the event a lawsuit is filed arising from my and/or my minor child's participation in activities offered by Sevier Air, my and/or my minor child's use of Sevier Air's facilities and equipment, any and all other disputes related to events occurring on Sevier Air's premises, any and all other disputes related to Sevier Air in any way, and any and all disputes related to this Release, including disputes related to the enforceability of any if the terms of this Release, I agree that sole and exclusive jurisdiction and venue shall be in Tennessee state courts located in Williamson County, Tennessee. I hereby expressly waive any defense to jurisdiction and/or venue that may now or hereafter exist.
- 9. Attorney's Fees.
